## Min.2017...Developments.

15/03146/STREM. Erection of 22 dwellings following outline planning permission 13/00305/STOUT(landscaping to be considered at land S,W & E of Austrothy House. After discussion, it was agreed that although various planning permissions for this site have been sought since 2007 councillors had no objections to this application.

## **Decisions from ERYC**

15/03339 Retention of entrance gates and fence at Boyes Lane Engineering. Granted Min.2018...Subcommittee updates.

a)...Playing fields. Cllr Lee and Cllr Lawton gave their monthly inspection report to the Clerk The graffiti on the youth shelter has been painted out by Cllr Lawton.Thanks to him.

The Annual playing field inspection has been received. Grass on Eastfield Rd park was recommended to be cut. It was pointed out that the weather has been too wet for any grasscutting to be carried out. A number of minor repairs are necessary on the playing equipment. It was disconcerting to note the inspector's comments on the new exercise equipment. There was no final inspection report when the equipment was handed over to the council. Minor adjustments will need to be made.

Red and yellow paint is required to freshen up the play equipment.

- b)....The Garth. See Councillors Forum.
- c).,,,Allotments. Request by resident to have half of an allotment was granted. Half plots need to be marked out for new tenants.
- d)....Churchyard. The gardener (Mr Kirk) advised that a bush at the Churchyard needs pruning and he will await permission from the Parish Council. This was given. Clerk to notify him in the morning.
- e)....War Memorial. No problems.
- f)....Cemetery. The tree stumps have not yet been ground out. Clerk to contact Mr Walby.

Page two.

Replacement trees still need to be purchased but until the stumps are gone this will have to wait. The cemetery shed is being emptied and handyman's equipment is being transferred to a shed at the village hall. Clerk has given a list of items to Cllr Thompson and Cllr Lawton.

g)...Streets & Verges. Uneven footpaths on Eastfield Rd and Owst Rd were reported some time ago to ERYC by the Clerk. Cllr J Kinnear has also reported it as a resident. The bus shelter graffiti was removed by a councillor.

Min.2019...Village Plan. Cllr Haxby reported that at a recent meeting of the Steering Committee, Phase two of the exercise garden was discussed, also the progress of Boyes Lane. A proposal for a Village street plan was made but where to put it is the problem.

Cuttings have been taken for the planters.

Youths of the village were invited to the steering group meeting but no-one turned up.

The KBS are having a Roadshow on Saturday 20<sup>th</sup> Feb from10am-4pm in the Rainbow Room of the village hall. The history of Keyingham will be on display and distribution of the remaining funds will be announced **Min.2020...Vacancy for Co-option**. No applications

Min.2021..Street cleaning update. Referred to in Clerk's update. Cllr J Kinnear wished to pursue the employment of a litter picker. After a lengthy discussion Cllr Simpson proposed that an Agency could be found to deal with this issue. That way all aspects including Tax & National insurance could be dealt with. This was seconded by Cllr D Clark. All in favour. Clerk will seek Agency details and report back in March. Min. 2022...Defibrillator familiarisation. See Clerk's update.

Min.2023...Youth Initiative. Cllr Haxby had received a deputation from some young people who were keen to have a skate park on the Saltaugh Rd playing field. Cllr J Kinnear has some detailed information which may be useful to the group.

Min.2024..."Say No" & "Stranger Danger" leaflets. This item was removed from the Agenda.

Min.2025...Councillors Forum. Cllr D Clark had looked at the Local Development Plan (forwarded by the Clerk) and added that whilst the document was very lengthy, there were no amendments to the plans involving Keyingham. He had attended the SHAPE meeting and the subject of interactive signs was discussed.

Cllr Clark added that concerns were expressed about the increased amount of traffic on the back roads to/from Withernsea were due to drivers avoiding the number of speed restrictions on the A1033. Karen Wood has agreed to ask a member of Highways to meet with SHAPE members to try to resolve this problem.

- .a) Cllr Haxby reported that on some mornings, alcohol is being drunk on the Garth. There is a no drinking sign on the Garth. To be reported to the police.
- .b) Cllr J Kinnear was concerned that with the "Forward" magazine being published every second month, by the time it reaches residents, many events have taken place. Cllr Haxby replied that once the magazine is written, it has to be proof read (by a volunteer) and then printed
- .c) Cllr Tindall asked I there are any plans to make the old shed on Waudby Garth Rd safe after the roof blew off recently. Cllr D Kinnear had spoken to the owner who was awaiting insurance outcome.
- .d) Cllr D Kinnear wished to have the wording on the "no dogs" sign clarified. Eventually it was agreed that the signs should be "Dogs must be kept on a lead at all times" at both entrances to the Garth.
